LIBBEY'S MAKERS PLATING CONTEST

ELIGIBILITY:

THE MAKERS PLATING CONTEST ("Contest") is open to legal residents of the 50 United States ("US"), Puerto Rico, District of Columbia, and Canada, excluding Quebec, who are at least 18 years of age (19 or older in US states AL and NE) at the time of Entry. Employees of Libbey Glass LLC ("Libbey") and other providers of the prizes (Collectively the "Prize Providers") and each of their parent companies, affiliates, subsidiaries, divisions, and advertising and promotion agencies, and their immediate families and household members are not eligible to enter or win. Up to 50 Entrants will be selected ("Participants") by Libbey and associated judges to participate and receive free Libbey plateware for use. Selection preference will weigh heavily on visual presentation of the ingredients on the plate, in the dish or the beverage. Not all who request participation will be chosen to compete.

COMPETITION PARTICIPATION:

If chosen as one of the 50 entrants to receive Libbey plateware, participants must submit a photo depicting an original dish plated on the Libbey plate sample that was shipped to them. The photo, including dish description in English, must be posted to a public Instagram account during the competition time frame. Any submissions that are posted outside of the competition timeframe will not be eligible to compete. Previous Makers Plating Contest winners will not be eligible to win future Makers Plating Contest competitions. The post must include the @libbeypro tag and the #makersplatingcontest24 hashtag. Competition posts must occur from April 29th, 2024 to May 5th, 2024, at 11:59pm. ("Submission Period"). Only one post will be counted as a contest submission per competitor. Libbey is not obligated to consider entries that are lost, late, misdirected, illegible, incompletely received, or incomplete, for any reason. Proof of sending will not be deemed to be proof of receipt. If a Participant's identity is disputed, the identity will be based on the authorized account holder of the Instagram account first used to submit during the competition phase and each Participant agrees to, upon Libbey's request, provide evidence sufficient to show that they are the authorized account holder.

PRIZES:

Winners of the following prizes will be selected.

1st prize package: \$1,000 or product at equal or lesser value

2nd prize package: \$750 or product at equal or lesser value

3rd prize package: \$350 and judge prize inclusions

If a desired prize is not in stock at the conclusion of the contest, Libbey will coordinate with winners to select an in-stock item.
